## CALABARZON RDC endorses the proposal to study the availment of P2P Bus System

The CALABARZON Regional Development Council (RDC) in its Full Council meeting on December 18, 2019 endorsed to the Department of Transportation and the Land Transportation Franchising and Regulatory Board the proposal to study the "Incentive for Government Employees Availing Point-to-Point (P2P) System."

The Sectoral Committee on Infrastructure Development (SCID) reported that mass transportation is critical in attaining the development goals of the Region. The ongoing construction of the Skyway Extension Project triggered traffic congestion along the South Luzon Expressway (SLEX). The use of P2P bus system was introduced as a strategy to decongest major thoroughfare in the Region and in Metro Manila.

The P2P mode of transportation, especially to employees who travel to work on a daily basis, will ease traffic congestion along the major expressway without compromising the overall quality of commuting experience and thus promote employee productivity.

The SCID recommends determining additional P2P routes to accommodate more commuters and identify possible incentives to encourage government employees to take the P2P buses.

The RDC also endorsed during the meeting the institutionalization of Community-Driven Development, support on the declaration of adolescent pregnancy as a national social emergency, Quezon-Bicol Expressway, and CALABARZON Transport Master Plan.

The RDC also confirmed the geographic representatives namely: Ms. Marilou G. Dinoy of Punta Fuego Village Foundation, Inc. for Batangas; Mr. Rodrigo M. Camia of Cavite Metro Multipurpose Cooperative for Cavite; Ms.

#### CALABARZON strengthens its GAD Resource Pool

The CALABARZON Regional Gender and Development Committee (RGADC) conducted the CALABARZON GAD Resource Pool (CGRP) Deepening Session Preparation on November 21 to 22, 2019 at the BP International Makiling, Makiling, Los Baños, Laguna. The activity is part of the continuous capacity development provided to CGRP members to further capacitate them in providing technical assistance on GAD.

The two-day training activity consisted of detailed discussions on sexual orientation and gender identity expression also known as SOGIE, gender analysis tools, and GAD Plan and Budget, as well as how to properly deliver the GAD core messages. Resource Persons from the Philippine Commission on Women (PCW) were invited to provide the necessary discussions and knowledge sharing. Through the session, the participants gained a deeper understanding on the core messages of

GAD and be able to effectively relay these messages to their audiences.

CGRP is a group of GAD practitioners in the region that was certified by the CALABARZON Regional Development Council (RDC) to address the increasing number of requests for technical assistance on GAD mainstreaming as well as to ensure the provision of quality technical assistance. In 2018, 11 GAD practitioners from different sectors were certified by the RDC as the CGRP Batch 1 following the certification guidelines adopted from the PCW National GAD Resource Pool Certification.

Due to the overwhelming demand on GAD technical assistance, RGADC will call for CGRP applications

for Batch 2 in the first quarter of 2020.

## CALABARZON students get first hand information on COVID-19 from DOH

The Department of Health (DOH)- CALABARZON continues its intensified health education campaign as it now targets schools in the Region to extend awareness and correct information on COVID-19 to help reduce fear and worry among students and their families.

"We have to properly educate and inform our students on what COVID-19 is all about to avoid confusion and panic and how it can be prevented. madalas lumalabas ng bansa upang umuwi o magbakasyon," stated DOH CALABARZON Director Eduardo C. Janairo.

"CALABARZON has no confirmed case of COVID-19 yet but health measures to contain and prevent its spread are in place should there be a need to implement an emergency procedure," he assured.

The DOH-CALABARZON Rapid Response Unit composed of Emerging and Re-emerging Infectious Disease Program, Health Emergency Management Service, Health Education and Promotion Unit and the Regional Epidemiology and Surveillance Unit will continue to visit schools and educate students on COVID-19.

A series of lectures about COVID-19, how it began, its symptoms, complications, transmission and prevention including national and global updates were given to grade 7 to grade 10 students including proper wearing and disposing of masks and hand washing.

Janairo encouraged students to help disseminate correct information to their families and avoid spreading fake news about the virus online.

## DA CALABARZON distributes additional PHP 32M worth of interventions to ASF-affected raisers in Rodriguez, Rizal

Agriculture Secretary William D. Dar and Regional Director Arnel V. de Mesa led the distribution of additional PHP 32-million worth of interventions composing of various farm tools, equipment, inputs, livestock, and poultry for hog raisers affected by African Swine Fever (ASF) in Rodriguez, Rizal on February 21, 2020 at Municipal Nursery in Brgy. Macabud, Rodriguez, Rizal.

The assistance is to help affected hog-raisers to have other sources of sustainable livelihood which they can grow even after the threat of ASF in the country disappeared.

Secretary Dar emphasized that the strong coordination between the Provincial Government of Rizal and Municipal Government of Rodriguez, with the Department of Agriculture CALABARZON is crucial to control and eliminate ASF in Rodriguez in just 30 days (August to September 2019).

There were 7,003 hogs culled due to ASF in the 1-7-10-kilometer zones affecting a total of 711 hog raisers in six barangays of Rodriguez were affected.



One of the initial interventions provided by the Department was indemnification wherein DA gave affected raisers P5,000 for each surrendered pig to be humanely culled.

According to Director de Mesa, the distribution of interventions is based on needs assessment and validation of affected raisers to ensure that the livelihood assistance provided to them is the most suitable and sustainable.

#### Laguna Province bags top DILG governance awards

The Province of Laguna was conferred its fourth Seal of Good Local Governance (SGLG) award by the Department of the Interior and Local Government (DILG) in November 2019.

The province passed 2019's polished and redefined 'Allin' assessment criteria with specific modifications in most of the governance areas namely: Financial Administration, Disaster Preparedness, Social Protection, Peace and Order, Business Friendliness and Competitiveness, Environmental Protection, and Tourism, Culture and the Arts.

Laguna was already inducted into the SGLG Hall of Fame in 2018, having been an awardee for three consecutive years.

Moreover, Laguna received the 2019 National Anti-Drug Abuse Council Performance Award in December. The award is given to LGUs for their effort and commitment in ensuring that their communities are drug-free, and in safeguarding their constituents from the adverse effects of illicit drugs.

The Province garnered a perfect score of 100 points, fully meeting the parameters set by the DILG in the 2018

#### Rizal is 2019 SGLG awardee

After being adjudged as the Most Competitive Province in the Philippines in 2019 for four consecutive years and receiving a favorable COA Report on Good Financial Performance, comes the prestigious Seal of Good Local Governance (SGLG).

The province of Rizal passed and was given "green" scorecards in all core and essential areas or the upscaled criteria, especially in environmental management, where the province performed well because of its YES (Ynares Eco System) Program which aims to safeguard the environment for future generations and combat the "climate change" phenomenon.

The award recognized LGUs in the practice of transparency, accountability and diligence in compliance with the Anti-Red Tape Act. The Province previously bagged the distinguished Seal in 2016 and 2017, aside from the Bronze and Silver Category in 2012 and 2013, respectively under its precursor the Seal of Good Housekeeping. # JOINING HANDS FOR TAAL VICTIMS

Last January 12, 2020, the Taal Volcano surprised everyone as it spewed ashes across CALABARZON, Metro Manila, and some parts of Central Luzon.

The Philippine Institute of Institute of Volcanology and Seismology (PHIVOLCS) raised Alert Level 4 which means hazardous eruption was imminent within hours or days. Ashfall blanketed the municipalities around the lake and frequent earthquakes destroyed houses and infrastructure forcing people to leave and seek to safer grounds.



Amidst the destruction brought by the eruption, the spirit of "bayanihan" lived on and prompted many to help the evacuees. Those unaffected by the eruption opened their doors to thousands of evacuees from greatly affected municipalities of Talisay, Laurel, Agoncillo and San Nicolas. Apart from the ecavuation center in Batangas and Cavite, other provinces in CALABARZON and even other regions sheltered the evacuees.



Different government agencies, non-government organizations (NGOs) and private individuals extended support to the victims of the Taal unrest. Donations such as clothes, food packs, medicines, drinking water, and personal necessities poured in. Cash and check donations have reached more than PHP39 million.

On the forefront, the Provincial Government of Batangas through its Provincial Disaster Risk Reduction and Management Office, Provincial Social Welfare and Development Office Provincial Health Office, other offices, together with the frontline national agencies including Philippine National Police, Department of Social Welfare and Development, Philippine Coast Guard, Office of the Civil Defense, Philippine Red Cross and volunteers from different NGOs and private individuals selflessly offered their time and risked their lives for

Batangueños to assist in the relief and

rescue operations.



Currently, the Provincial Government of Batangas under the leadership of Governor Hermilando I. Mandanas, is working on building long term plans for permanent resettlement with livelihood to help victims, particularly those living at the Taal Volcano who will be displaced.

#### NEDA joins relief efforts for Taal Volcano victims

The relief goods, composed of clothes, water, food, medical supplies, blankets and beddings, were donated by employees of NEDA Central Office and NEDA Region IV-A, and canned goods from Ms. Victoria Wienke of the Kabisig ng Kalahi Inc., a Private Sector Representative (PSR) of the RDC CALABARZON. The goods were received by the Taal Heroes Group at the National College of Science and Technology (NCST), Dasmariñas City, the Cavite central distribution center.

Average inflation rate slightly increased by 0.37 percentage points from the last quarter but significantly lower by 3.6 percentage points from last year.

#### Top contributors to the increase in **Consumer Price Index**



The main drivers of higher consumer price index were the prices of alcoholic beverages and tobacco, food and non-alcoholic beverages, furnishings, household equipment and maintenance, and clothing and footwear. Prices of alcoholic beverages and tobacco grew by 9.1 percent and 24.8 percent, quarter-onquarter and year-on-year, respectively while prices of food and non-alcoholic beverages increased by 1.5 percent quarter-on-quarter and 1.1 percent year-onyear. Prices of furnishings, household equipment and maintenance went up by 0.9 percent from last quarter while clothing and footwear increased by 0.8 percent.

The increase in prices of commodities was expected due to the high consumption demand during the holiday season. The last quarter constituted the time of the year where consumers tend to spend more on food gifts and other recreational activities which in effect, raises the prices of commodities.

#### Consumer Price Index & **Purchasing Power of Peso**

The average consumer price index for this quarter increased by 0.93 points quarter-on-quarter, from PHP118.6 from last quarter to PHP119.7 this quarter while the average purchasing power of peso remained the same.


Figure 3. Quarterly purchasing power of peso, 3<sup>rd</sup> Quarter 2019 and 4th Quarter 2019

#### Labor & Employment\*



Fourth quarter's labor force participation rate is estimated at 64.1 percent which is lower by 0.03 percentage points quarter-on-quarter but 1.80 percentage points higher year-on-year. Decrease in the labor force participation rate can be attributed to more students in the working population age who pursue higher education, especially those in senior high school.

Employment rate increased by 1.40 and 0.50 percentage points quarter-on-quarter and year-on-year, respectively. Increase in the employment rate can be attributed to increased job openings in sales and retail as demand for goods and services increased during the holiday season.

Meanwhile, retrenched establishments decreased by 16.34 percent compared with last year and 1.41 percent compared to the previous quarter. This affected 9,412 employees, of which, 65 percent were from Cavite, where most of the retrenched establishments are located.

Shutdown cases increased by 95 percent as compared to the previous quarter; hence, the number of affected employees surged fivefold. Cavite Province recorded the most shutdown cases at 15 establishments which affected 2,628 employees.

Redundancy of workers, lack of market, financial loss, and non-renewal of leasing contract were some of the reasons for retrenchment and shutdown.

#### Agriculture & Fisheries\*

Production losses were recorded for major agricultural crops and livestock during the fourth quarter of 2019 compared to the same quarter in 2018. However, production of poultry and fisheries generally increased in the same period.

#### **Crops**

Majority of the crops monitored in the region, such as, palay, corn, sugarcane, coconut and banana displayed production downtrend while production increased on coffee, pineapple, sweet potato, and cassava.

Palay production at 140,146 metric tons in fourth quarter of 2019 was 8.64 percent lower than production of 153,400 a year ago. Corn production also contracted from 36,129 metric tons to 22,367 metric tons while coconut production slightly declined from 385,868 metric tons to 374,165 metric tons for the same time period. Sugarcane and banana recorded a significant reduction in production from fourth quarter of 2018 to fourth quarter of 2019 with 53.42 percent and 2.71 percent losses, respectively. On the other hand, coffee production was up by 11.50 percent from the 149 metric tons in fourth quarter of 2018 to 166.14 metric tons for the same quarter in 2019.

Pineapple, sweet potato and cassava production improved by 5.91 percent, 4.14 percent and 2.53 percent, respectively. Pineapple production expansion may be attributed to newly opened pineapple plantation areas due to high market price while significant increase in coffee production may be attributed to the aggressive promotion and interventions for the coffee industry.




Figure 5. Percent contribution of agriculture, livestock, poultry and fisheries sub-sector to the total production, 4<sup>th</sup> Quarter 2019




Figure 6. Volume of fisheries production, 4th Quarter 2019

The total volume of fisheries production increased by 9.36 percent in the fourth quarter of 2019 compared to the same period last year. The positive performance can be attributed to the significant increase in production of municipal fishing by 23.86 percent and aquaculture fishing by 9.36 percent. On the other hand, commercial fishing declined by 33.14 percent due to Typhoon Tisoy and Ursula.

#### **Livestock and Poultry**

Livestock production declined by 1.06 percent in the fourth quarter of 2019 compared to the previous year. Hog and cattle production contracted by 0.56 percent and 8.45 percent, respectively. Hog production went down as demand slumped due to the African Swine Fever outbreak while cattle production declined due to limited stocks available for slaughter in the Region. On the other hand, poultry production expanded by 8.29 percent due to increase production in chicken, duck, and eggs.

Total cargo throughput declined by 11.98 percent compared to last year but higher by 14.32 percent compared to the previous quarter.
The increase in cargo throughput can be attributed to the holidays as both domestic and international

in Batangas.

cargoes increased by 37.21 and 18.12 percent, respectively. On the other hand, lower cargo throughput compared last year can be attributed to fewer cargoes in private ports.

The holidays brought an increase of passengers by about 26 percent compared to last quarter and 0.77 percent compared to last year. Higher numbers of passengers embarked and disembarked at the Port of Batangas and Port of Nasugbu.

#### **Lucena Port and Private Ports in Quezon**




Figure 10. Total shipcalls in Lines Lucena Ports and Private Ports of 2019. in Quezon, 4<sup>th</sup> Quarter 2019

Total ship calls at Lucena Port and other private ports in Quezon increased by about 12 percent and 3 percent compared last quarter and the previous year, respectively. Increase in ship calls can be attributed to resumption of fastcraft and RoRo vessels of Montenegro Shipping Lines in the 4<sup>th</sup> quarter

There was a significant increase on passengers that disembarked and embarked in the Port of Lucena. Compared to the previous quarter, passengers disembarked increased by 27.92 percent while those that embarked increased by 38.92 percent.




Figure 11. Total passenger traffic in Lucena Port and Private Ports in Quezon, 4<sup>th</sup> Quarter 2019

#### **Cargo Throughput**




Figure 12. Total Cargo throughput, 4th Quarter 2019

Total cargo throughput declined by 12.92 percent compared to the previous quarter but increased by 12.29 percent compared to the previous year. Total cargoes handled in the Port of Lucena and private ports declined in the 4<sup>th</sup> quarter of 2019. On the other hand, compared to last year, there was a 14 percent increase in foreign cargoes in Mauban and Pagbilao ports due to importation of coal.



#### **Development Prospects and Challenges**

- Inflation rate will remain within target for the upcoming months as the base effects of 2018's inflation rate continues to wear off.
- ◆ The implementation of 2020 excise tax tranche of TRAIN will likely pull up prices of transportation and fuels for the first quarter of 2020.
- The impact of damages to agriculture by Taal eruption's may increase prices of commodities but the Corona virus (COVID-19) outbreak may slow down global prices. Thus, offsetting any domestic price changes.
- ◆ Livestock production is expected to slow down as the African Swine Fever continues to threaten the swine industry while the impact of the Taal Volcano eruption might negatively affect production of coffee, corn, pineapple and aquaculture fishing in the Region.
- The continuous spread of COVID-19 in Asia and other continents may affect numerous industries including tourism, manufacturing and agriculture resulting to reduced production, and retrenchment and shut down of small enterprises.

#### **RPMC 2020 First Quarter Meeting**

The CALABARZON Regional Project Monitoring Committee (RPMC) conducted its first quarter meeting on February 6 at NEDA Region IV-A, Barangay Milagrosa, Calamba City. The Committee discussed various topics for approval, adoption, and information.

The Committee approved the 2019 RPMC Accomplishments and Revised Guidelines on the Search for Outstanding Local Project Monitoring Committees (LPMCs). Likewise, the RPMC adopted the RPMC Fourth Quarter 2019 and First Quarter 2020 Field Inspections Reports for the Manila Bay Rehabilitation Program, Quipot Irrigation and Macalelon Small Reservoir Irrigation Projects and Querocep Bridge Project. The outcomes of the RPMC Problem-Solving Sessions for Lobo-Malabrigo-Laiya-San Juan Road and Sariaya Bypass Road Projects were also discussed and the recommendations to facilitate project implementation were approved.



Moreover, updates on the following projects were noted by the Committee: a) Sangley Airport Development; b) New Centennial Water Source – Kaliwa Dam Project; and c) Cavite Industrial Area Flood Risk Management Project.

## RPMC Approves the Revised Guidelines: Search for Outstanding LPMCs




RPMC approved the Revised Guidelines on the Search for Outstanding LPMCs during its first quarter meeting.

The Search for Outstanding Local Project Monitoring Committee is an annual activity of the Committee that aims to motivate, strengthen and sustain the LPMCs in monitoring and facilitating the implementation of development projects at the local level. All LPMCs at the provincial, city and municipal levels are included in the Search.

The Search's Guidelines were revised to further assess and determine the status and functionality of LPMCs. The Revised Guidelines will be used starting in 2021 to evaluate the 2020 Accomplishments of the LPMCs.

Meanwhile, the 2020 Search will be conducted from February to April where the 2019 Accomplishments of the LPMCs will be evaluated. Awarding of the outstanding LPMCs will be in second quarter RDC meeting.

## Construction of Querocep Bridge to be completed in March 2020



The access to Infanta, Quezon from the National Capital Region is expected to improve with the completion of the Querocep Bridge along the Marikina-Infanta Road in March 2020. The bridge collapsed in December 2015 due to Typhoon Nona.

The bridge will pave the way for the transport of local products from the REINA (Real, Infanta and General Nakar) area to Manila and viceversa. This will also open more opportunities for tourism and other economic activities in the Region.

The construction of the Querocep Bridge was delayed due to unfavorable weather conditions and the road cut in the Infanta Section which hampered the transport equipment for the construction of the bridge. The CALABARZON Regional Project Monitoring Committee conducted the field inspection of the Bridge on January 30.

#### **RPMC Bulletin**

#### Solid Wastes continue to Accumulate in Manila Bay Clean-up Sites



The Manila Bay Rehabilitation Program aims to rehabilitate and restore Manila Bay water to SB level (i.e. recreational water class 1 and fishery water class 3). The Program components include the comprehensive clean-up and rehabilitation of priority rivers, installation of trash traps, and mapping and ground delineation of easement area in CALABARZON.

On December 20, 2019, the CALABARZON RPMC conducted field inspections of selected clean-up sites in Cavite Province. Among the implementation issues were the persistent

accumulation of solid waste in clean-up sites, presence of informal settler families along priority rivers and lack of available materials recovery facilities and sanitary landfills in Cavite Province.

The RPMC recommended for DENR Region IV-A to continue coordination with DILG, DPWH and concerned LGUs on clean-up activities and include in its priority projects the establishment of materials recovery facilities and sanitary landfills in Cavite Province. Moreover, they should coordinate with the Department of Human Settlements and Urban Development on the relocation of informal settler families, and finalize the CALABARZON Sanitasyon at Basura Watch Program. DENR was asked to establish trash traps in barangay boundaries to determine accountable LGUs on solid wastes.

#### Major Irrigation Projects of NIA Region IV-A Inspected by CALABARZON RPMC

The CALABARZON RPMC in cooperation with Quezon PPMC conducted field inspections of Quipot Irrigation and Macalelon Small Reservoir Irrigation Projects of NIA Region IV-A in Quezon Province on January 29.

The Macalelon Small Reservoir Irrigation Project (MSRIP) aims to irrigate around 830 hectares of farmland in 10 barangays in Macalelon, Quezon which will benefit around 700 farmers. The MSRIP involves the construction of a 22-meter high zoned earthfill dam and appurtenant structures



including irrigation, flood control, and aquaculture components. Among the implementation issues of the Project were ROW acquisition, delayed payment of landowners due to absence of proof of land ownership, and peace and security issues. NIA Region IV-A continues to coordinate with concerned agencies and LGUs to fast track payment of landowners and resolution of ROW issues and ensure peace and security in the area.

Likewise, the Quipot Irrigation Project (QIP) involves the construction of a barrage-type dam to irrigate about 2,800 hectares of new agricultural areas. The Project will benefit the farmers in the Municipalities of Tiaong, Candelaria, and Sariaya

in Quezon and San Juan in Batangas. During the field inspection, NIA Region IV-A was requested to submit to the RPMC the details of their release of payment requests to DBM and prepare a briefer on the decreasing value of palay in the market due to Rice Tariffication Law. The issue on palay prices will be discussed in the second quarter meeting of the Sectoral Committee on Economic Development of the RDC.

The CALABARZON RPMC will continue to monitor and facilitate the implementation of these two major irrigation projects in Quezon Province.
